The St. Tammany Parish School Board will receive sealed bids until 2:00 p.m., Monday, June 5, 2023 on Novar Controls. Bids shall be in accordance with the following instructions and attached specifications and bid form.

- 1. <u>Bids shall be submitted on the attached bid form.</u> Bids shall be sealed in an envelope clearly marked on the outside, "<u>BID ON NOVAR CONTROLS June 5, 2023</u>."
- 2. All bids shall be received by the St. Tammany Parish School Board Office located at 321 N. Theard Street, Covington, LA 70433 by one of the methods outlined below. All bids arriving after this date and time will be returned unopened to the bidders. Bids may not be withdrawn for at least thirty (30) days following the scheduled closing time for receipt of bids.
- 3. Bids may be sent via registered or certified mail, UPS or FedEx with a return receipt requested, hand delivered, or submitted electronically.
- 4. Bids may be submitted electronically at <u>www.centralbidding.com</u>.
- 5. You may find related bid materials including detailed specifications necessary to complete your bid at <u>www.centralbidding.com</u> and/or <u>www.stpsb.org/bids</u>.
- 6. All prices shall include delivery charges to St. Tammany School board sites and <u>prices shall be</u> <u>good through June 30, 2024.</u> Orders will be placed as supplies are needed.
- 7. Sales tax <u>IS NOT</u> to be included in your bid price. St. Tammany Parish School Board is exempt from sales tax as provided by LA R.S. 47:301(8)(c). Sales tax exemption only applies to purchases between St. Tammany Parish School Board and the contractor/vendor. Sales tax exemption does not apply to purchases made directly by the contractor/vendor to other companies on behalf of the school board. Those purchases are not sales tax exempt.
- 8. <u>All bids must be accompanied by a bid security</u> in the form of a bid bond, certified check, cashier's check or money order in the amount of five hundred dollars (\$500.00). <u>Bids will not be considered unless the required bid security is provided and in the correct amount.</u>
- 9. If submitting a bid electronically, then bid security must be in the form of an original, valid fully executed bid bond and be included in your bid submittal. STPSB must be able to verity the validity of the bond within 72 hours. If bonding company cannot validate within this timeframe, bid may be awarded to next lowest responsive bidder. Cashier's check, certified check or money order will not be accepted for an electronic bid. Failure to comply will cause your bid to be non-responsive.

- 10. Successful bidder must consent to and yield to the exclusive venue and jurisdiction of the 22nd Judicial District Court for the Parish of St. Tammany, and waive any and all claims of entitlement to removal of any case from this jurisdiction, including any removal to any Federal Court, in connection with any proposal or bid.
- 11. If bidding items other than as specified, bidder shall include catalog cuts and descriptive literature with the bid item number clearly marked/labeled on each sheet for identification purposes. This information should be included in the bid response with the completed bid form.
- 12. It is the intent of the specifications to invite bids on high quality merchandise. Mentioning a brand, manufacturer, and number is done only to establish the standard of quality desired. It is not the intent to eliminate brands of equal quality but instead to set forth and convey to prospective bidders the general style, type, character, and quality of the product desired.
- 13. The School Board reserves the right to select a higher priced item where, in the judgment of the School Board, such item is of superior quality or design or would be more suitable for the purpose intended. The School Board further reserves the right to adjust quantities by increasing or decreasing and to reject any and all bids.
- 14. Cash discounts, if offered for a period of thirty (30) days or more with the beginning date to be determined by the date of invoice or date of delivery whichever occurs last, will be taken into consideration in determining the low bidder.
- 15. In accordance with LA Revised Statute 38:2252, "Preference is hereby given to materials, supplies and provisions, produced, manufactured or grown in Louisiana, quality being equal to articles offered by competitors outside of the state." As bidder you must indicate on your bid response that you are claiming a preference.
- 16. The School Board further reserves the right to adjust quantities by increasing or decreasing and to reject any and all bids.
- 17. In accordance with Revised Statute 38:2237 A(9), the School Board may reject all proposals when it is deemed that such action is in the best interest of the School Board.
- 18. Bid opening will be available for public observation at the St Tammany Parish School Board Office located at 321 N. Theard Street Covington, La 70433 at 2:00 PM on June 5, 2023.
