The St. Tammany Parish School Board will receive sealed bids until 2:00 p.m., Thursday, June 8, 2023, on Supplies for Graphic Arts in accordance with the following instructions and attached specifications.

- 1. Bids shall be submitted on the attached bid form. All conventional paper bids shall be either hand delivered or sent by registered or certified mail, UPS or FedEX with a return receipt requested to the St. Tammany Parish School Board Office, 321 N. Theard Street, Covington, Louisiana 70433, in a sealed envelope clearly marked on the outside "BID #1837 ON SUPPLIES FOR GRAPHIC ARTS JUNE 8, 2023." All bids arriving after this date and hour will be returned unopened to the bidders. No bid may be withdrawn for at least thirty (30) days after the scheduled closing time for receipt of bids.
- 2. Bidders also have the option to submit bids electronically. Please find bid related materials and place electronic bids at www.centralbidding.com.
- 3. At the time set for the opening of bids, their contents will be publicly opened and read aloud for the information of bidders and others properly interested who may be present in person or by representative.
- 4. All <u>unit prices</u> shall include delivery and handling charges and any other charges (ie., hazmat fee) to the St. Tammany Parish School Board Graphic Arts Department, 71460 Edna Street, Covington, Louisiana 70433. Prices shall be good through June 30, 2024.
- 5. Sales tax <u>IS NOT</u> to be included in your bid prices. St. Tammany Parish School Board is exempt from sales tax as provided by LA R.S. 47:301(8)(c). Sales tax exemption only applies to purchases between St. Tammany Parish School Board and the contractor/vendor. Sales tax exemption does not apply to purchases made directly by the contractor/vendor to other companies on behalf of the school board. Those purchases are not sales tax exempt.
- 6. Bidders may bid on one item only, all items, or any combination of items. Name brand, model number and unit price must be included on bid form whether bidding as specified or equal. If bidding items other than that specified, bidder shall include catalog cuts, descriptive literature, and state brand and model number of item being bid.
- 7. All bids shall be accompanied by bid security in the form of a bid bond, certified check, cashier's check, or money order in the amount of Five Hundred Dollars (\$500.00). Bids will not be considered unless the required bid bond or check is attached.

- 7. If submitting a bid electronically, then bid security must be in the form of an original, valid fully executed bid bond and be included in your bid submittal. STPSB must be able to verify the validity of the bond within 72 hours. If bonding company cannot validate within this timeframe, bid may be awarded to next lowest responsive bidder. Cashier's check, certified check or money order will not be accepted for an electronic bid. Failure to comply will cause your bid to be non-responsive.
- 8. Successful bidder must consent to and yield to the exclusive venue and jurisdiction of the 22nd Judicial District Court for the Parish of St. Tammany, and waive any and all claims of entitlement to removal of any case from this jurisdiction, including any removal to any Federal Court, in connection with any proposal or bid.
- 9. Cash discounts, if offered, will be taken into consideration in determining the low bidder. <u>DISCOUNTS LESS THAN THIRTY (30) DAYS WILL NOT BE CONSIDERED IN MAKING AN AWARD.</u> Beginning date for discount period shall be determined by date of invoice or date of delivery of merchandise whichever occurs last.
- 10. Orders will be placed as supplies are needed through June 30, 2024.
- 11. In accordance with LA Revised Statute 38:2252, "Preference is hereby given to materials, supplies and provisions, produced, manufactured or grown in Louisiana, quality being equal to articles offered by competitors outside of the state." As bidder you must indicate on your bid response that you are claiming a preference.
- 12. It is the intent of the specifications to invite bids on high quality merchandise. Mentioning a brand, manufacturer, and number is done only to establish the standard or quality desired. It is not the intent to eliminate brands of equal quality but instead to set forth and convey to prospective bidders the general style, type, character, and quality of the product desired.
- 13. The School Board reserves the right to select a higher priced item where, in the judgment of the School Board, such item is of superior quality or design or would be more suitable for the purpose intended.
- 14. The St. Tammany Parish School Board reserves the right to reject any and all bids and to increase or decrease the number of facilities to be serviced.
